***STAR CRUISES FURTHER EXTENDS AMENDED ITINERARIES***  
***Positive Guests Comments Alleviate Anxiety on Cruising on Amended Itineraries***

Star Cruises wishes to inform that the amended itineraries for ***SuperStar Virgo's*** and ***SuperStar Gemini's*** respective **3-night cruises** will be temporarily extended further to **sailings on Sunday, 9<sup>th</sup> January and 16<sup>th</sup> January 2005.**

This is in relation to the amendment of both ships' itineraries where calls to Phuket have been cancelled since 27<sup>th</sup> December 2004 following the *tsunami* catastrophe.

With the latest extension, Star Cruises would have cancelled calls to Phuket for 4 weeks.

Star Cruises will continue to monitor the situation in Phuket for the next two weeks, at the end of which the Company will announce the changes accordingly.

Passengers who are currently cruising on ***SuperStar Virgo*** and ***SuperStar Gemini*** on the amended itineraries are safe. The cruise and shore excursion activities in Langkawi and Penang have been smooth and incident-free as areas damaged by the *tsunami* are isolated. Both ships are expected to arrive in Singapore and Port Klang tomorrow as scheduled.

A recent guest comment survey conducted onboard ***SuperStar Virgo*** and ***SuperStar Gemini*** sailing on the amended itineraries, in the wake of the recent *tsunami* disaster, has garnered very positive comments by guests from Singapore, England, Australia, Philippines, India, Malaysia, Mauritius and South Africa.

The majority of respondents, many of whom had cruised more than once with Star Cruises and also on other leading cruise lines were duly impressed with the levels of service, facilities and amenities found onboard.

Of interest is the high confidence that the guests expressed with regards to the many safety aspects of the cruise and did not feel that they were in any danger. Most were impressed with the passenger drills conducted prior to sailing, the safety standards practised onboard, the safety features that ***SuperStar Virgo*** and ***SuperStar Gemini*** are equipped with and the confidence with which the crew performed their safety tasks.

The survey also revealed a consistency in terms of peace of mind that guests enjoyed during the cruise and appreciated the reason for the change in itinerary.
